

DISTRICT 15 MONTHLY MINUTES

October 2, 2007

Meeting opened at 6:45 pm by George K., DCM with The Serenity Prayer.

Roll Call: Six officers, eight GSR s, and one past DCM for a total of 15 eligible voting members.

Secretary Report: Reviewed, motion to accept as read by Bernie C. with second by Jody K. Unanimously approved.

Treasury Report: Ann reported a current balance of \$424.65. The bank statement was circulated for review. Scott R. made motion to approve with second by Gary O. Unanimously approved.

DCM Report: George K. reminded all of the October 7, 2007, Area 60 Fall Assembly at the Butler Days Inn. He will be attending and encourages GSR s to attend. He will be speaking with the other districts interested in combining Fall Day of Sharing 2008.
